Forms List



This forms list is a selection of forms to assist you in your application only should your circumstances require it - Only use these forms if your circumstances require it.

Your required documents and forms to enable you to lodge your Partner and Sponsorship applications are outlined in your 'Required Documents' list.

Section 104 of the Migration Act requires that you keep the Department of Immigration updated throughout the processing of your application with any changes in your circumstances such as contact details (phone, email, mail or residential address, change in passport, employment, education etc). Generally speaking, you should notify the department of any change in you or your partners life that would affect an answer you provided on your visa or sponsorship applications.

Some of the department's forms can now be completed online through your immi account once your application is lodged and do not require a paper-based form, these include the following;

- Appointment or withdrawal of an authorised recipient Someone who receives correspondence on your behalf
- Change of address details
- Change of email address details
- Change of passport details
- Notification of changes in circumstances
- Notification of incorrect answer(s) that you provided in your application
- Permission to travel outside Australia during processing Bridging Visa B application

The above online forms are available and visible in your online visa application once lodged, and are located under the 'Update Details' Tab on the left side of your lodged online visa application.

An online application for a Bridging Visa B (permission to travel outside Australia during processing) is available under the Tab (Bridging Visa) on the







Forms List Frequently used Forms



Form 80 - Personal particulars for assessment including character assessment (The department may request this Form from you or your partner if your case officer has questions or to seek clarification on your background for character checking. You are not required to complete this form to lodge your visaor sponsorship applications and it may not be requested by your case officer)

Form 888 - Statutory declaration by a supporting witness for a Partner Visa (You are required to provide at least 2 of these forms with your partner application – see 'Required Documents' list. It is recommended that you provide 4-6 of these completed forms with your application where possible)

Form 929 - Change of Address/Contact details and/or Passport details (available online)

Form 956a - Appointment or withdrawal of an authorised recipient (available online)

Form 956 - Advice by a migration agent/exempt person of providing immigration assistance (available online)
